What personal information will be disclosed?

The information may include (not but limited to):

- Personal information:
 - contact details
- Immigration status
 - current visa status, including visa held
 - visa grant number
 - visa expiry dates
 - ongoing visa application, including type and date lodged
- Conditions attached to your visa
- Travel authority
- Other authorised recipients.

Why are we asking for your consent?

The Department may need to disclose your personal information with domestic and family violence service providers, community groups or advocates to ensure they can provide you with support and services.
