



Transcript – Applying for a subsequent protection visa

If you have a Temporary Protection visa or a Safe Haven Enterprise visa it is your responsibility to know your visa conditions, including the visa expiry date. Your current Temporary Protection visa or a Safe Haven Enterprise visa, along with access to any benefits and work and study rights will be extended until there is a decision on your new application. If you need help with your application you can use a registered migration agent, at your cost. Ensure the migration agent is registered with the Office of the Migration Agents Registration Authority.
